#### 1. To receive apologies for absence

3. Minutes of the last meeting held on 10 January 2023

#### 4. Reports

#### 4.1 To receive updates from County / District Councillors

- 4.1.1 North Norfolk District Council
  - Further to the discussion at the last meeting, Cllr Dixon reported that there
    was in fact no compensation for a missed bin collection. It was agreed that
    it was not helpful for NNDC to advertise the Serco contact details as the
    parishioners contract is with the District Council and therefore it is NNDC
    whom should be contacted in the first instance.
  - ND had followed up the warm hub grant query with the community connector and advised the situation via email to the parish council.
  - The early intervention number for NNDC was highlighted for anyone in the community who was in hardship: 01263 513811 help <u>intervention@north-norfolk.gov.uk</u>
  - A household battery recycling scheme would be starting soon. Batteries should be placed in small plastic bags and placed on top of the main bins and they could then be disposed of. It was hoped the scheme would start in the next couple of months.

#### 5 To receive updates on ongoing matters:

- a. Wildlife East Group
  - There was nothing new to report
- b. Black Shed update

A quote had been received for the damp course injection of £160. It was hoped that two more quotes would be sought. There have been problems getting quotes for the roof due to the nature of the work. There has been one quote received for the roof of about £14k. Martin will ask Adrian.

c. New Victory Hall update

DD reported that all building works had been completed. The Bands Evening raised over £1k with half being donated to Air Ambulance and half donated to the hall funds. The AGM would take place on Monday 27<sup>th</sup> March with an opportunity for public attendance and refreshments at the end. There was a range of forthcoming events planned including a quiz.

d. Instead Staithe – lease (HM)

HM reported that she had received a letter back to say that the Broads Authority did not want to enter into negotiation about the lease of the staithe. HM will send another letter back. It was suggested that honesty boxes were placed in the car park and for mooring.

- e. Queen's Platinum Jubilee 2022 trees and tree guards (HM and GN) The Chairman reported that the tree planting for the Queen's Platinum Jubilee had been successful with trees being planted in all three parishes. It was hoped that there would be an event to celebrate the forthcoming King Charles III Coronation.
- f. Defibrillators (HM)

The Broads Authority replied to a letter regarding placing an defibrillator raising some points and concerns regarding the installation. DD would find out the cost of running the defibrillator in order to respond to the queries raised. It was noted that Roger was happy to have one on his barn and Phil was happy to have one on his gates. The discussion continued regarding the best place for the defibrillators.

#### 6. Highways Issues

- The planting along Mill Road and the bushes that need cutting back.
- Common Road had been re-surfaced but large grit has been placed on the top. GN would speak to highways.
- GN had spoken to Neville Drake (farmer) regarding the mud on Pennnygate Road, which had now been swept.
